1. Please attach your recent photo when registering.
2. Contestants must ensure all personal information in Application Forms are accurate and true. Anyone found with falsified information will be disqualified. Information will be made available for use by contest organizers.
3. All contestants must provide a valid contact/telephone number that can directly contacted the contestants' parents/guardians at any time.
4. All contestants must abide by rules and regulations of the contest; The organizer reserves the right to have the final say and decision.
5. Contest organizer reserves the right to disqualify contestants who fail to abide the by rules and regulations.
6. All contestants automatically grant permission to the Contest Organizers (local and foreign), Cooperating Organizers, and existing global media (or future media) the use of personal information including (but not limited to) photographs and/or videos, statements, printing of names as well as recordings from performances (entirely or partially) for advertising, promotional and publicity purposes on media including (but not limited to) TV, newspapers, magazines, radios, and the internet.
